He thanked the UAB representatives for the movement they are working toward and wished them success. He also asked for prayers for our District Attorney.

Commissioner Parker commended Dr. Lavender, GSCC Interim President, on the job she does and said her oldest son was planning to go to Gadsden State and then later transfer to UAB. She feels Gadsden State has a good partnership with UAB.

Commissioner Choate thanked Gadsden State for what they do for this county. He said he was contacted by a good friend about the UAB situation and he wanted to do the proclamation to try to show the Commission stands behind them and what they are trying to accomplish. He asked for prayers for Jimmy Harp.

Commissioner Payne said he had taken courses at GSCC and at JSU. He said we appreciate all they provide for the county including the technical and service training programs. He added that UAB was a fine institution and hoped they were able to get the football back. The athletics are an important part of education. He thanked them for coming and said he was glad they brought their cheerleader.
