The request of Jeff Little, Personnel Director, to transfer Elizabeth Quinn to Benefits Coordinator, effective June 7, 2016. This is a promotion to be paid from the General Fund, Personnel Department, at an hourly rate of \$14.62.

PASSED AND ADOPTED THIS 7th DAY OF JUNE, 2016.

The following item was on the Agenda: 'To approve the replacement of the County Vehicle provided for the Etowah County Coroner to use in his official capacity as Coroner by Option A: Option B; or Option C as listed below.

Option A: Transfer the 2013 Dodge Ram Truck (VIN# CRR7GT2DS556821) for use in his official capacity as Coroner. This is a four-wheel drive, extended cab pickup with a bed liner with less than 50,000 miles.

A motion was made by Commissioner Statum for Option A but the motion failed for lack of a second.

Option B (if needed): Purchase a truck from the state bid list with the total cost not to exceed \$30,000. This option will require a budget amendment.

There was no motion made on this option.

Option C (if needed): Let bids for a truck with the total cost not to exceed \$30,000. This option will require a budget adjustment.

A motion was made by Commissioner Choate and seconded by Commissioner Parker. In the discussion portion, Commissioner Choate stated that he supported Option C because of the agenda item to let bids for the (2) 2016 Small SUV's for the Reappraisal Dept. He said he believed we should treat all of the requests for vehicles the same.

Commissioner Statum said he thinks to bid it out will be a waste of the taxpayer's money when we have a truck available that is worth \$25,000 that anyone would be glad to have as a work truck.

Commissioner Fuller agreed with Commissioner Statum.

Commissioner Parker said she also thought we should be consistent in how we handle the requests.

Commissioner Payne asked what happens to surplus vehicles and Kevin Dollar was asked to make a statement. He said we either declare the vehicle surplus or it gets 'bought' by another department. If declared surplus, we sell it on Gov Deal website. Commissioner Payne asked if we had a written policy and Kevin Dollar said 'no'.

Commissioner Statum said we are in compliance with the Local Act if we didn't even get him a vehicle (because he has a county car he drives no and also a county van). Also, we have a vehicle in inventory worth \$25,000 and if we let bids, it will cost \$30,000 to let bids for a new vehicle and we will have to make a budget adjustment because this vehicle was not included in the budget. He said everyone drives a 'used' vehicle, plus it will delay the time it takes to get him a better vehicle and cost more money. He understands we are trying to do things in a fair way but does not think we should bid it out.

Commissioner Choate said a new vehicle will have a 3 to 5 year warranty and then you will also have the longevity that goes with that. We can transfer the other vehicle to Engineering and then get rid of one of their worst trucks.

Commissioner Statum said we would have to pull money out of reserves.

Commissioner Parker said we needed to have a written policy from the Commission.

Commissioner Fuller requested a roll call vote on Option C.

Commissioner Statum – No; Commissioner Fuller – No; Commissioner Payne – No; Commissioner Parker – Yes; and Commissioner Choate – Yes.

Option C failed to pass with only 2 affirmative votes.
