The Etowah County Commission met in a regular meeting on the 20th Day of February, 2018. Commissioner Overstreet called the meeting to order at 10:00 am and led the Prayer and Pledge to the Flag.

She also talked about **Skywarn**, a 1st Responder Storm Spotter Training on March 21st from 10 am - noon at the EMA Office and asked everyone to share with any first responders.
