

**MINUTES OF THE REGULAR MEETING  
OF THE ETOWAH COUNTY COMMISSION  
ETOWAH COUNTY, ALABAMA  
September 21, 2021**

Commissioner Jamie Grant called the meeting to order on the 21st Day of September, 2021 at 9:00 am with Probate Judge Scott Hassell asking the Prayer and Commissioner Jamie Grant leading the Pledge to the Flag.

**PUBLIC COMMENTS FROM ELECTED OFFICIALS AND OTHERS:** There were several elected officials at the meeting because it was the last meeting before Linda Barrett-Vaughan, Revenue Commissioner, will be retiring.

These responders were thanked for their service and assistance after this traumatic event.

Shane Ellison, CAO, presented Linda Barrett-Vaughan with a Proclamation from the Commission to thank her for her years of service as the Revenue Commissioner. She served for 12 years and was now looking forward to her retirement. Linda said it had been an honor to serve and that ‘it takes a team’. She said she couldn’t have done it without the help of her employees and they did not get the recognition they deserved.

Commissioner Washington thanked the Officers and First Responders for what they do and said he was thankful they have the passion for what all they have to do. He thanked Linda for her years of service.

Commissioner Ramsey thanked Linda for always being positive and having a good attitude of being here to serve and to explain to people, in a way they can understand, why they have to pay what they are required to pay. Regarding the 9/11 Responders, he said he still sees how the people have been effected by the trip to help at Ground Zero and thanked them for all they do.

Commissioner Johnny Grant thanked Linda for being a good friend and helping him all these years. He also talked about his appreciation that Sheriff Hayes let all of the responders go to Ground Zero on 9/11 and took the responsibility for any controversy over them going.

Commissioner Statum thanked Linda and says he knows they have disagreed through the years over a few things but he appreciated her and she always answered when he called and helped anyway she could. He said he appreciated her passion and that it doesn't go unnoticed. She did what she was elected to do at the highest service. Regarding the 9/11 Responders, he said he couldn't say enough for all they did and We Will Never Forget!

Shane said he worked with Linda during the Covid Pandemic and after the shut-down, when the buildings first reopened and noticed that she and her Assistant, Ginger Lindsey, were going person –to-person down the line to check the paperwork and make sure it was everything needed to prevent customers from standing in line and getting to the desk only to find out they didn't have all of the items that were required to get their tags. He was appreciative of all she did to help out her employees and the customers. The FOP and Sheriff's Office have requested to have a Trick or Treat in the Parking Lot of the Courthouse on October 30<sup>th</sup> at 6:00 pm and the Commissioners were all fine with the request.

**ADJOURN:** The Chair then entertained a motion to adjourn the meeting. Upon motion of Commissioner Washington, seconded by Commissioner Statum with all other members voting “yes”, the motion was passed. The meeting was adjourned at 10:30 am.
