MINUTES OF THE REGULAR MEETING OF THE ETOWAH COUNTY COMMISSION ETOWAH COUNTY, ALABAMA March 21, 2023

PUBLIC COMMENTS FROM CITIZENS:

Laura King with New Life for Women discussed her program located in West Etowah County. In business since 2005, it is a treatment center for chemically dependent women. It is certified but not ran by the state. It costs about \$7,000 for one person to spend 6 months there and they do get some funding but it's not enough. They have 2 facilities with a total of 52 beds with most of their clients staying at least 6 months. They would also like to open an outpatient clinic for Community Corrections and are trying to get funding toward this project as well. She is requesting the county to use some of the Opioid settlement funds to help her facility so they can expand.

Fred Zachary wanted to see if the Commission planned to make a change concerning the late fee on the property tax – he was at a previous meeting discussing why he considered it unfair to tax everyone that pays late the same, even if they are both late. (Sometimes the late penalty is more than the tax bill). The Commission told him they were looking into a solution and are hoping they can come up with something.

Jeff Johnson, Principal at Etowah Middle School, brought a few students on the Robotics Teams to the meeting. They had 3 teams (with 3 students per team) that went to State and now 2 teams will be going to the World Competition in Dallas, Texas. Principal Johnson also pointed out all the teams learn from working on their projects including technology, coding, programming, record-keeping, documenting failures/successes, and with the process in general teaching them to work together and solve problems. The students are in the 6th & 7th grades and they cost will be about \$6600 to attend on April 29 through May 3rd. They appreciate any help they can get to pay for their trip.
