#### **DISCUSSION BY COMMISSIONERS**

Shane announced that County Day will be next Tuesday in Montgomery so we will not have a work session on April 11, 2023.

Commissioner Washington thanked everyone for coming.

Commissioner Ramsey recognized the Family Success members (Emma & Katie) in the meeting asking for help for their programs. Family Success Center is there to help the Commissioners with needs in their Districts and Tim said he would like to see about a food bank at schools so kids can take food home for the weekend. He thanked Glencoe Mayor Hare for coming.

He also thanked the Sheriff and Eric for all they do.

Commissioner Jamie Grant thanked Emma & Katie and said he appreciated all they do. He also thanked Mayor Hare. He said the tornado they had in Sardis was and EF1 or 5 if it hits your house. He said sometimes people don't realize how big deal it is until it hits their house. They had a robbery on the Mountain and arrested someone yesterday – a person was running in a store and stealing stuff. We have a good law enforcement here and we don't need to take them for granted. They need our support to keep us safe because they put their lives on the line every day. It was a long weekend for them because they were hunting a bank robber and had a stand off yesterday.

Commissioner Johnny Grant agrees with Jamie totally. He said the crash (in the news) was horrible and it could happen here.

Commissioner Statum thanked the Mayor for giving them an update regarding the red light and said he appreciated all he does. He also thanked Katie & Emma from Family Success Center for all they do.

Commissioner Inzer talked about the baseball fields at GSCC and the ribbon cutting. He said there were a lot of teams and also soccer practice going on. The Gadsden City fields are really nice. He also agrees with Jamie on law enforcement and said there's always something going on even if they are just riding and looking out for problems. He also talked about Project Scout (City of Gadsden) and how the original draw for the company was the Megasite but they needed something smaller. It will mean about 350 jobs for the county and Gadsden is down to the final 2 in the selection process after they started with about 75 locations. He said there were adjustments made for the tax abatement offered. He talked about the Sports Hall of Fame and Danny Carlisle and said this is an organization he plans to donate funds to. He thanked everyone for coming.
