DISCUSSION BY COMMISSIONERS

Commissioner Washington thanked everyone for coming.

Commissioner Ramsey thanked Rainbow City for their work on Township Road and on other roads. He thanked Robert for finding money to fix the roads and is glad to have extra money for the water tank.

Commissioner Jamie Grant said he appreciated the first responders for all they do when we have storm damage and the road department. He said the Road Dept doesn't get the thanks they deserve. He added that we are paying millions for the roads to be fixed and then they are falling apart in less than 2 years. He asked everyone to keep the people on the mountain in their thoughts and prayers because some lost their houses and people were hurt (in the recent storms).

Commissioner Johnny Grant thanked everyone involved for helping with the cleanup. He said he was proud of the coroner and what a good job he has done. He does a great job and is qualified to be the coroner. He said he was proud of the work that was being done on the Megasite.

Commissioner Statum said the Road Dept recently used some new equipment they had purchased to widen Green Valley Road and it does a great job. They are still working on the road now but he said it looks great.

Commissioner Inzer named some of the people he had a chance to talk with at the recent Economic Development Conference (IDA, Dept of Commerce) and several from Etowah County also attended. They talked about the County getting the recent grant from Norfolk Southern while some counties don't even have land for new industry. He believes we have turned the page on what these people think of us by working together and having positive press concerning out project. He said recently, the Secretary of Commerce discussed the Etowah County project first in an Economic Development Meeting and it was the largest on his list.

Jamie Grant said the narrative has changed for Etowah County and reminded everyone of the ground breaking on part of the Megasite project after the meeting today.
