#### **DISCUSSION BY COMMISSIONERS**

Sheriff Horton thanked all of the Commissioners, Kevin, and Shane and said it means a lot to him and his employees for them to give them raises with nearly a \$4 an hour increase over the last 3 years. He said he appreciated that they did what they could, even though it wasn't as much as they asked for, but he knows and appreciates that they did their best.

Commissioner Washington said he was glad the municipalities are going to start paying for their jail use and 'this will really help us in the long run'. He also thanked Kevin and Shane for their work on the budget and said he was looking forward to the Unity Tree Ceremony on November 27<sup>th</sup>.

Commissioner Ramsey welcomed Tina Morrison from the Greater Tourism Board. He thanked the Family Success Center for their work on the Community Garden. He said he was glad they were able to get the budget together for the employees and was glad the Sheriff is closer to where they need to be. He thanked Kevin and Shane for the additional money in the road budget and said he was glad the bond will be paid off to free up that money. He said we can only do what we can afford to do and Robert and his crew do a great job.

Commissioner Jamie Grant said you won't find a Commission anywhere that cares as much about their Sheriff's Office as this one does, enough to forego their raises to make sure there was more funding for the Sheriff's Office employees. He said they are here to serve the people of Etowah County and not here to get rich. He thanked Kevin and Shane for their hard work.

Commissioner Johnny Grant agreed with Jamie and said all of the employees needed a raise and he felt like the Commissioners did all they could to make that happen.

Commissioner Statum said it is great what Team work can accomplish. He thanked the employees for their hard work and said people just don't realize how many accounts Kevin has to deal with on a daily basis. He thanked the Sheriff and his department for all they do.

Commissioner Washington said he was glad they were able to absorb the insurance cost increase.

Commissioner Inzer said sometimes benefits get lost in the shuffle and he was also glad they were able to absorb the insurance cost increase and still give employee raises. He said they talk about the Sheriff's Office a lot but it's a big department. This is the largest budget the county has ever passed. The presentation gives everyone an idea of where the money comes from.

<u>ADJOURN</u>: The Chair then entertained a motion to adjourn the meeting. Upon motion of Commissioner Johnny Grant, seconded by Commissioner Tim Ramsey, with all other members voting "yes", the motion was passed. The meeting was adjourned at 10:00 am.
