Commissioner Inzer said he was also jumping on the bank wagon because the Sheriff's Office had a lot of papers to be served and they have to be signed for. It takes multiple trips sometimes to get in touch with someone. He said he doesn't agree with the Commissioners having to pass the Resolution or it being put back on them. He said they can pass a bill without having to have a resolution from the Commission. He said he was a team player and would agree with this resolution because papers have to be served but he may not be in favor of some other bills that will be coming down the road.

Commissioner Ramsey said he would like for the Senator and Sheriff to pass the bill without Commission involvement but now we have to make up for the lost funds from the pistol permits.
