## **DISCUSSION BY COMMISSIONERS**

It will take about 18 months to complete and will cause interruptions and delays during the process but will be better once it is completed. There will be a public meeting on the bridge project on June 20<sup>th</sup> at the Southside Community Center. Everyone is encouraged to attend.

Commissioner Washington thanked the leadership at the Sheriff's Office and commended the improvements in the turnover rate. He congratulated Eric on his promotion at the Extension Office. He reminded everyone of the upcoming Juneteenth Celebration taking place on Saturday, June 15<sup>th</sup> at the Amp. It will start around 1:00pm and he encouraged

everyone to attend. He discussed a recent poll that considered Alabama as being one of the worst places to live in the country (7<sup>th</sup> from the bottom).

Commissioner Jamie Grant discussed more ways to get the county roads cleaned up from the trash. He also discussed a recent survey that place Alabama close to the bottom of the list concerning education in the country and said he would like to see that improve. Dr. Cosby pointed out that Etowah County was above the state average in the literacy rates but were continually working on improvements. Jamie said he would like to see the State Legislators make better choices in Montgomery to improve education. He thanked Dr. Cosby for all he does for the kids and said he appreciated everyone coming to the meeting. He congratulation Dena Cook on her Board Appointment to DHR. He thanked the department heads for all they do and said he felt they were doing a great job in the jail. He reminded everyone of the ribbon cutting for the new Fire Department in Southside and said there were a lot of graduations coming up.

Commissioner Ramsey thanked Robert Nail for his continued work on Pleasant Valley Road. He said he appreciated how quickly he worked to get those issues resolved. He thanked Barry Smith for the jail improvements and getting the turnover rate down. He thanked Eric for being here and he thanked Dr. Cosby. He congratulated Dena Cook and thanked Ms. Terri Vosbury and said he hoped the meetings go well this week. He thanked Melissa for all she does and said he was looking forward to the Juneteenth Celebration. He said Randall Green (with American Legion) was having a car show at the Fairgrounds as a fundraiser and Rainbow City will be having a drone show at the end of the month to celebrate Independence Day.
