Begin at a point, being the intersection of the centerline of Tillison Road and a projection of the western property line of Lot Number 1 in Block Number 2 of J. M. Hood's Redivision of Lots 1 thru 7, Parcel 1, Riverview Estates as shown in Plat Book E, Page 103, in the Judge of Probate Office, Etowah County. From said Point of Beginning, run west along said centerline to a point of point of tangency of with a curve to the left between Tillison Road and Riverview Drive; thence run along the centerline of said curve and continue to run southerly along the centerline of Riverview Drive to a point, being the of intersection with a projection of the southern property line of Lot 11 in Helen's Rearrangement of Lots 30 and 31 in Parcel One in Riverview Estates Bk. C Pgs. 402 & 403, as shown in Plat Book H, Page 74, in the Judge of Probate Office, Etowah County, said point being the end of said right-of-way.

DISCUSSION BY COMMISSIONERS

Commissioner Inzer thanked Alabama Power for all they do and said everything was slowing down a little, waiting on November. The EDAA meeting was good and he thanked everyone for listening to his concerns on the Challenger Center. He also thanked Ms. Sullivan for all she does and the Sheriff's Office as well as several others in the meeting.

Commissioner Jamie Grant said he was glad they approved the Tillison Road annex to Gadsden. He said he spent a couple of days riding the roads in his District, along with Robert Nail, and all-in-all, they were in good shape. He said you can't expect all of the roads to look like 278 without making everyone pay a lot more taxes. He thanked Chiho for coming to tell them about Agape Nation.

Commissioner Statum thanked everyone for hearing what he had to say about Tillison Road. He asked everyone to put it on their calendars for September 11th from 11:00 to 1:00, they will have free hot dogs & hamburgers for the First Responders at Sam Boswell Honda. He said he would have a flyer to hand out later.

Commissioner Ramsey thanked Spencer Williams (with Alabama Power) for coming to the meeting. He also thanked Eric Wright for being here and said he hoped they could work with him on getting grant money for projects. He said we are responsible for the county roads and we are falling further behind. 'We are not getting it done!' He said 3 of the Commissioners have the most of their roads in the city limits and so it is not their problem but the budget is underfunded. He said the recent rains are not helping the road conditions and we need to do something as a commission. It's something they need to look at and see what they can do better. He talked about the recent passing of the wife of Billy Ray Williams (former Commissioner) and former Commissioner Butch White.

<u>ADJOURN</u>: The Chair then entertained a motion to adjourn the meeting. Upon motion of Commissioner Inzer, seconded by Commissioner Jamie Grant, with all other members voting "yes", the motion was passed. The meeting was adjourned at 10:30 am.
