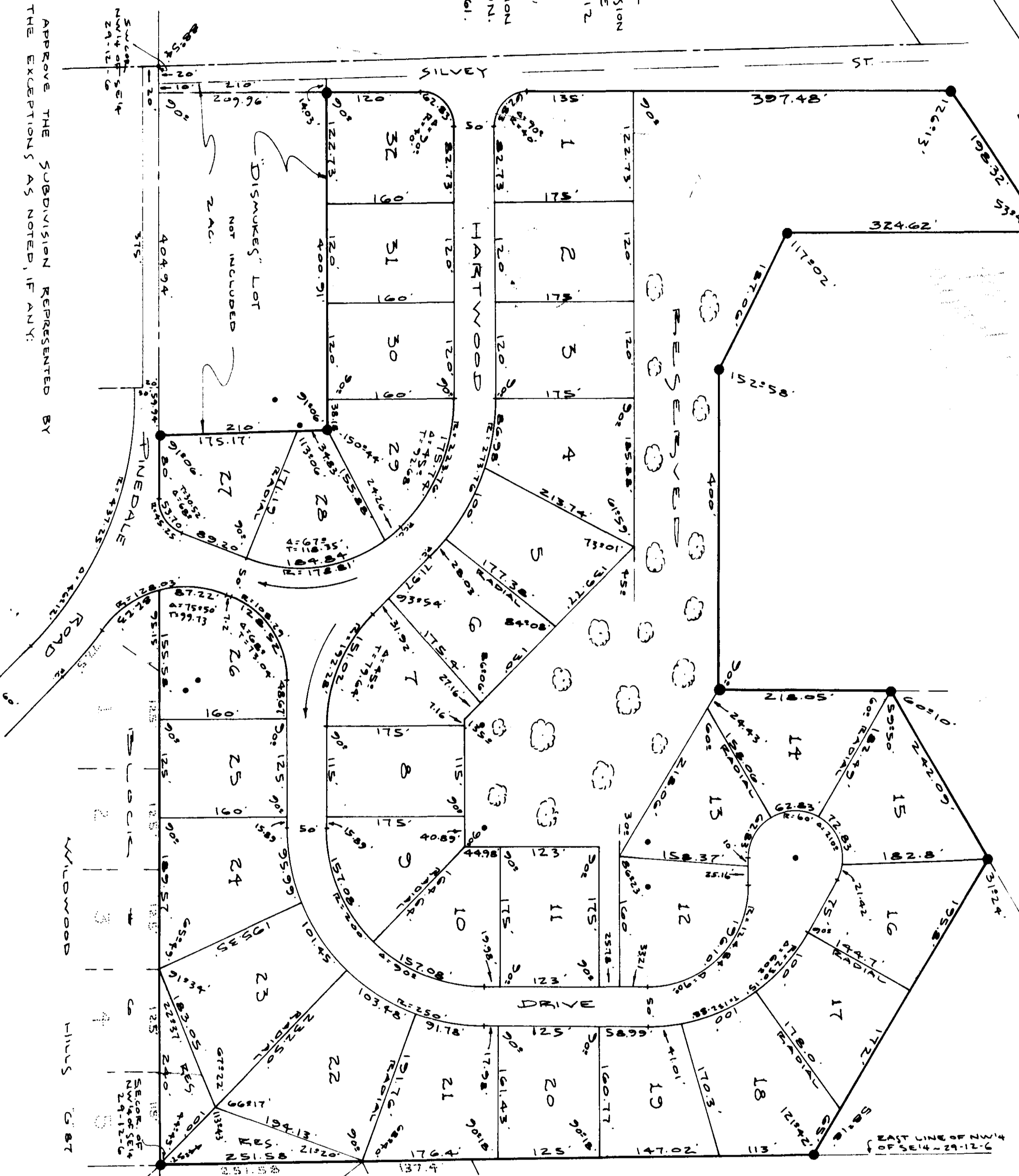


WILDWOOD ESTATES
