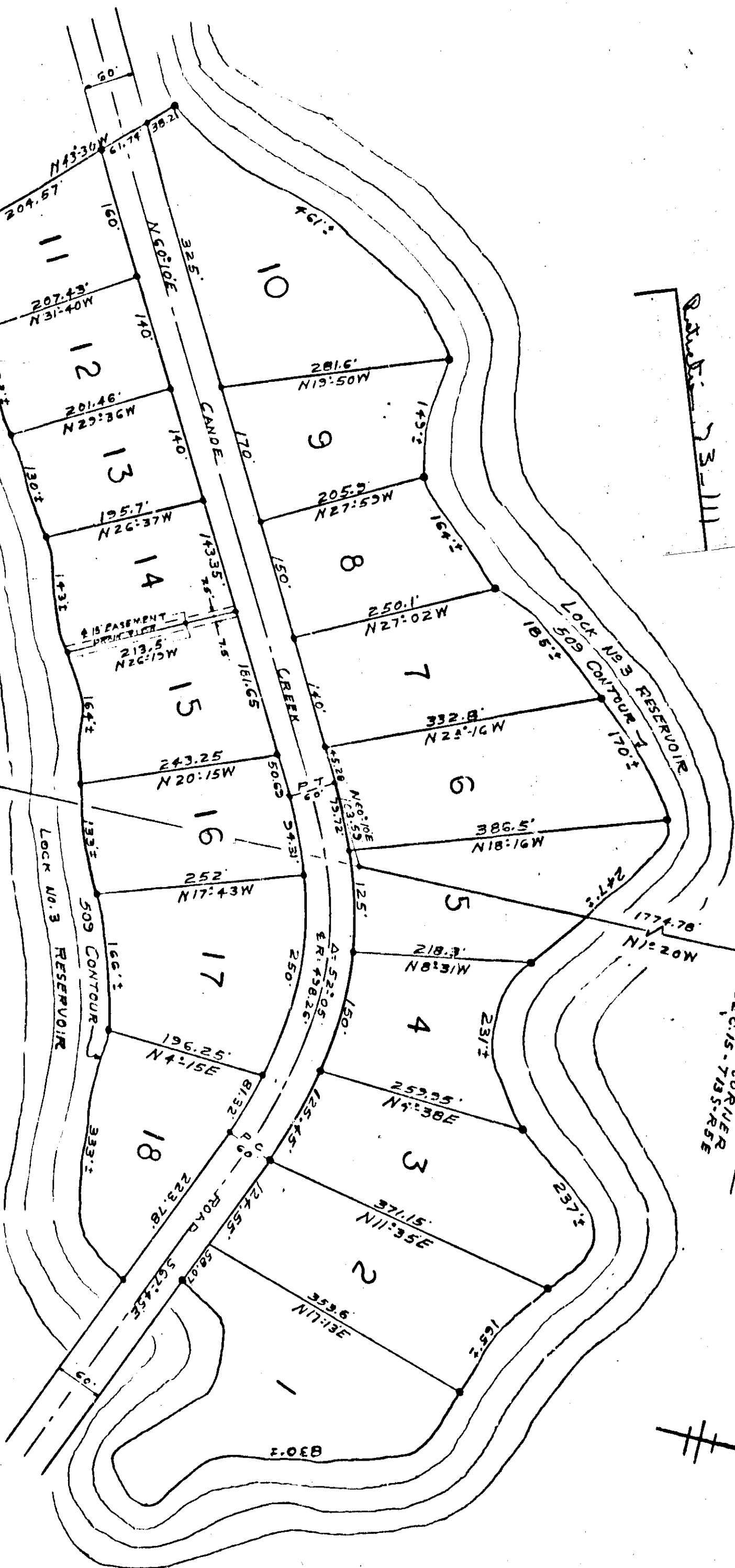
RAINBOW ISLAND
