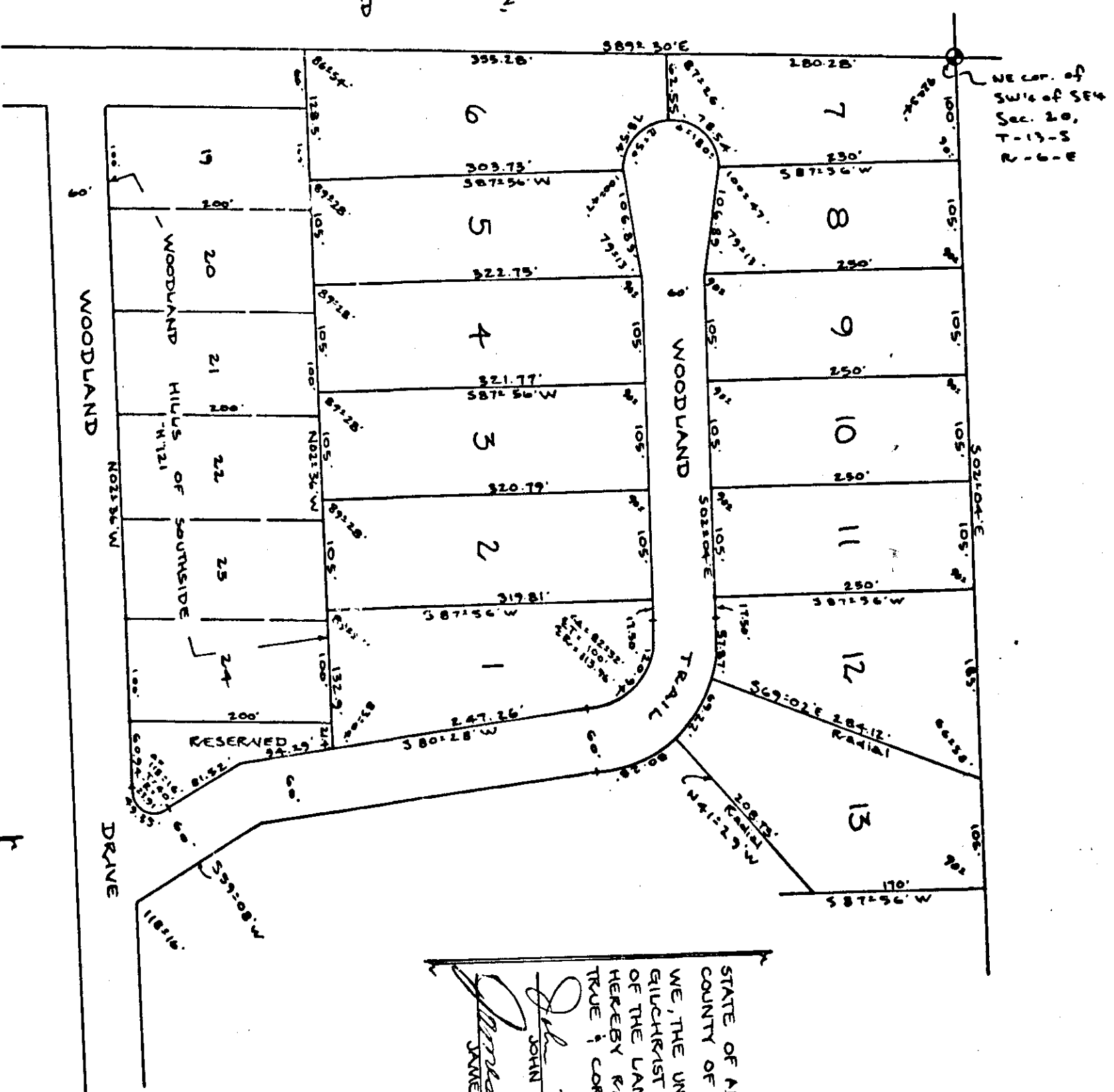


# WOODLAND HILLS of SOUTHSIDE
