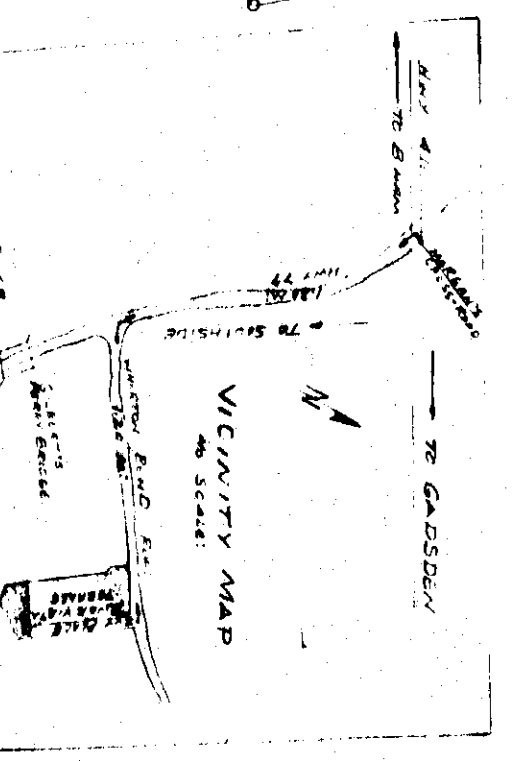
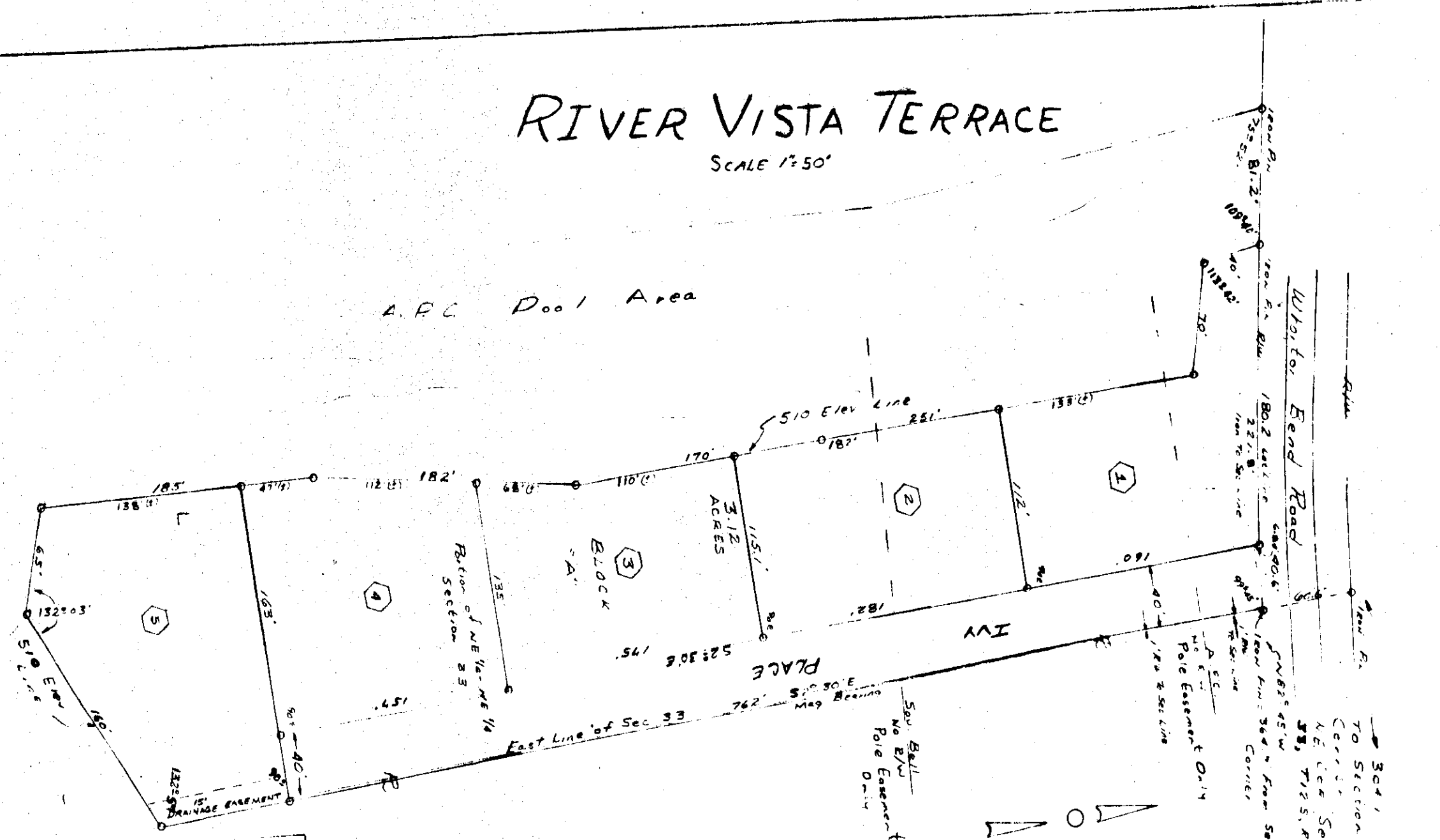


RIVER VISTA TERRACE

A.P.C. Pool Area



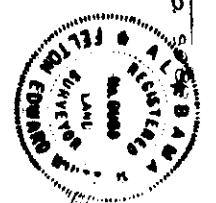
