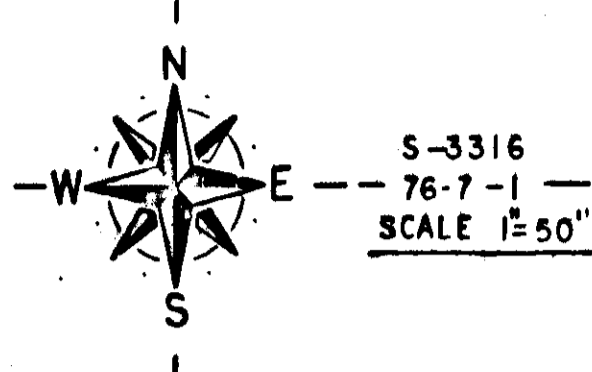
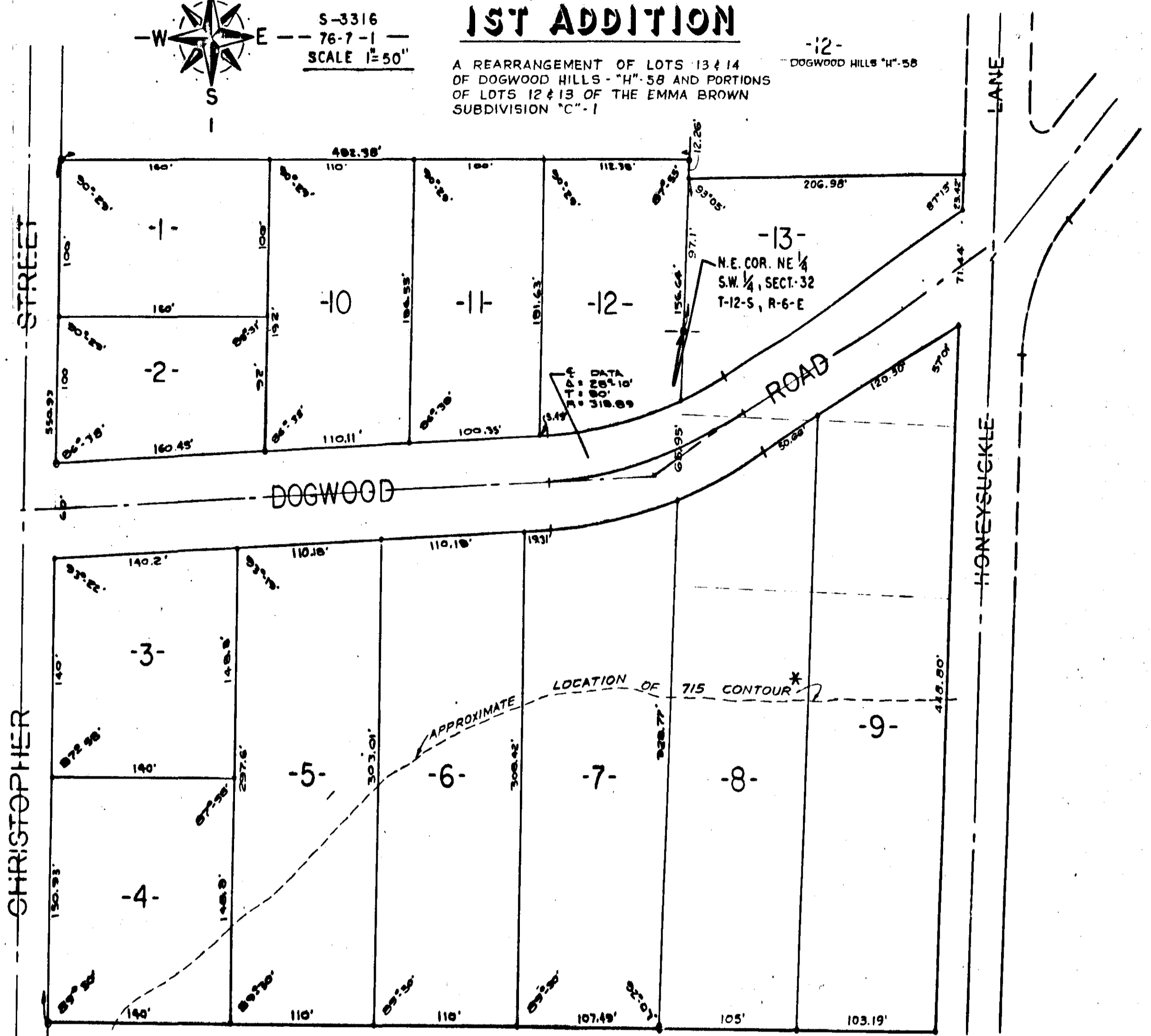


**DOGWOOD HILLS
