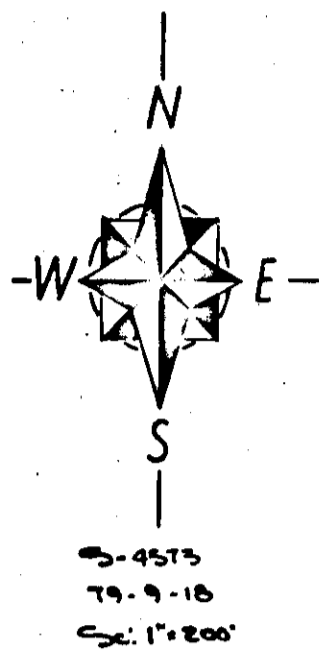


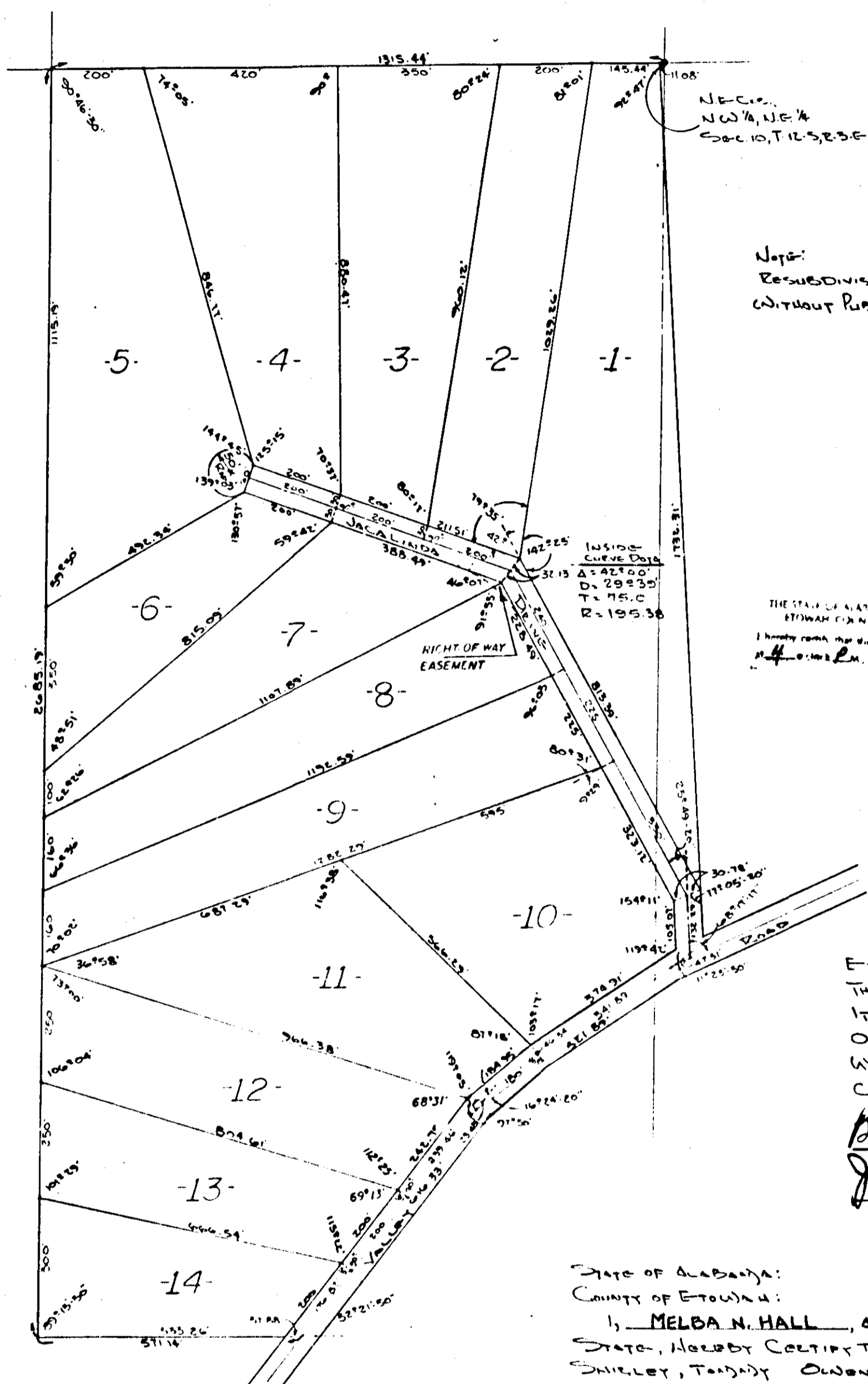
MOODY'S CHAPEL ESTATES
