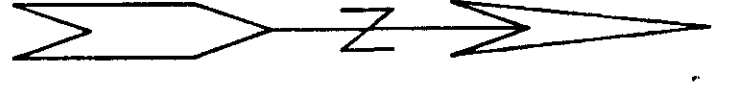
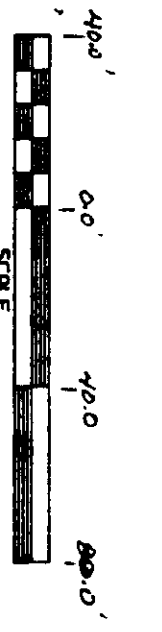

RERRANGEMENT OF LOTS 18, 19, 20 AND PART OF 21 OF HAWTHORNE ESTATES I-16

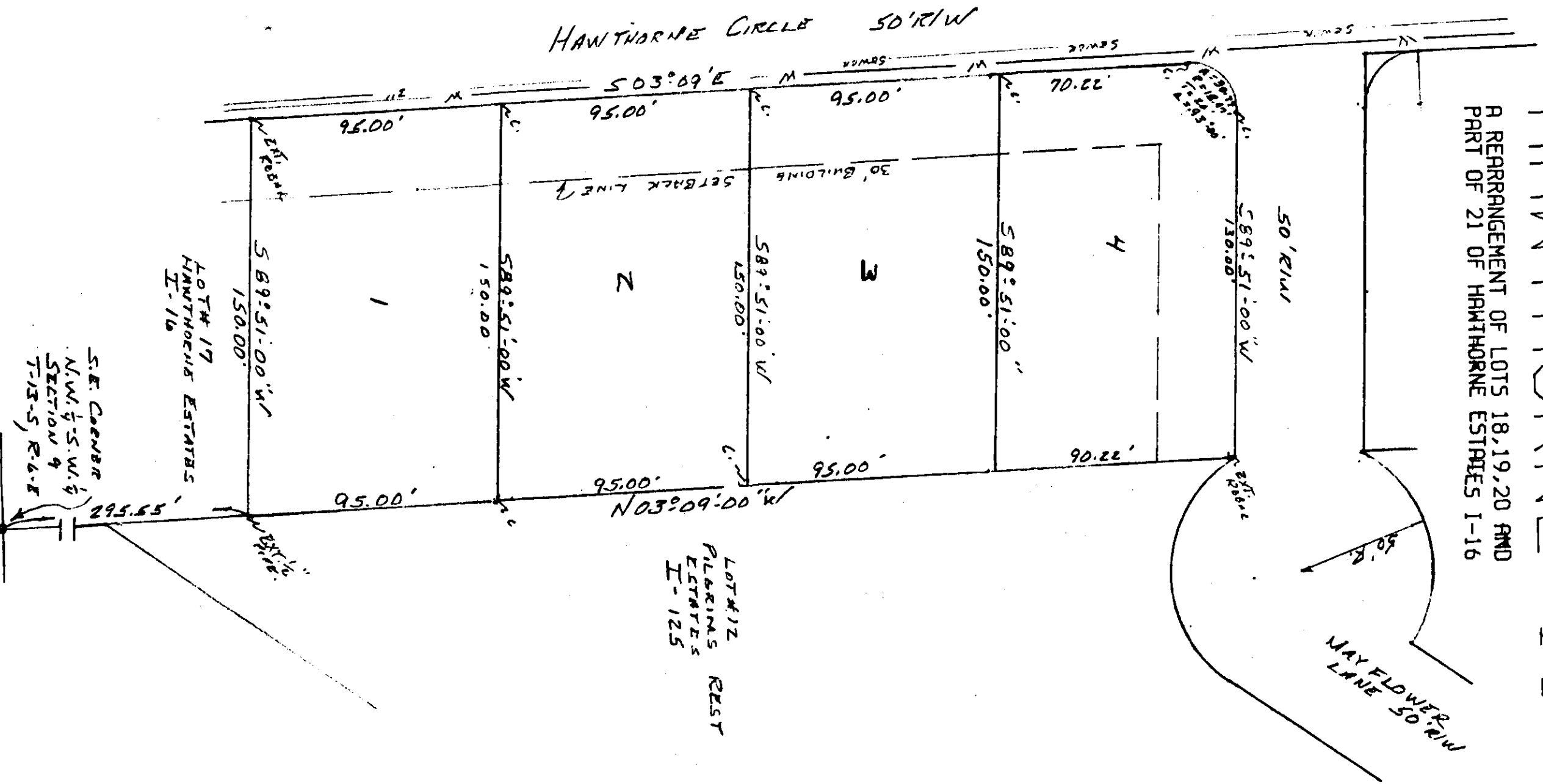
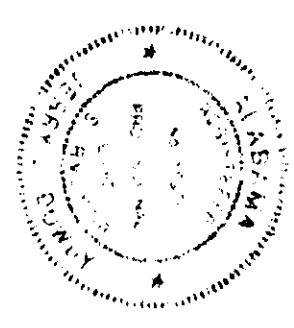


NORTH BY PLAT
