The Etowah County Commission met in a regular meeting on the 27th Day of September, 2016. Commissioner Fuller called the meeting to order at 10:20 am. Commissioner Choate led the Prayer and Pledge to the Flag.

#### **REPORTS FROM THE STAFF:**

Chief Administrative Officer: No Report.

**County Engineer**: No Report. **County Attorney**: No Report.

Other: No Report.

Commissioner Statum asked the Commission President if we can make a recommendation on Item A to amend it to include a 2½% pay raise for the employees and vote on it again. Sherrie Kelley stated she didn't think the Commission could vote on an item that had died for lack of a second but she could call Mr. Turnbach for his opinion. He was in litigation and would have to be left a message and return the call.

Commissioner Fuller called for a motion to recess to give Sherrie time to get an answer to the question and to discuss options available so they could come to an agreement and pass the budget. Commissioner Choate made a motion, which was seconded by Commissioner Overstreet, with all 6 Commissioners in agreement. The Commissioners recessed for an open discussion in the workroom at 10:30 am.

## **Discussion during recess**:

During the recess Commissioner Statum, Commissioner Fuller, Commissioner Payne, Commissioner Overstreet, and Commissioner Choate moved to the work room for the discussion portion; along with the County Clerk, Karen Bates; Deputy Administrator/CFO, Kevin Dollar; CAO, Sherrie Kelley; Sheriff Entrekin and Cyndi Nelson with the Gadsden Times. This was an open meeting and there were a few other people in and out during the discussions.

After checking on the guidelines, Sherrie Kelley recommended the Commission add an item to the agenda, which had to be approved by all Commissioners present, to amend the General Budget (001) to include the pay raise. Commissioner Choate asked if the raise could be a lesser amount but Kevin Dollar stated that is the minimum raise that could be given to keep the steps, which were set up by the study with Condrey & Associates, as they are. Commissioner Choate discussed the need to have a dialog with the legislature to hopefully free up money for the counties. After discussion, Commissioner Statum requested an item be added to amend the General Budget and give a  $2\frac{1}{2}$ % raise to the associates. The addition of this item was approved by all Commissioners present.

Commissioner Payne then requested an item be added to remove the appropriation of \$5,000 to purchase software licenses from the Commissioner Budget. All Commissioners present agreed to have the item added to the agenda.

Sheriff Entrekin spoke to the Commissioners during the recess and requested that he be given an additional deputy plus personal protection equipment to give him an added deputy for each shift. All Commissioners present agreed to add the additional deputy plus personal protection equipment to the budget for the General Fund - Sheriff's Office.

These 3 items, which pertain to the General Fund, were added to the Agenda.

Commissioner Fuller reconvened the meeting at 11:20 a.m. in the Commission Chamber. The Commissioners that were present include: Commissioner Statum, Commissioner Fuller, Commissioner Payne, Commissioner Overstreet, and Commissioner Choate. Commissioner Parker was absent.

Commissioner Fuller asked Sherrie Kelley to read the 3 added items, and he called for a motion on each:

Upon motion of Commissioner Statum, seconded by Commissioner Payne, with all Commissioners voting "yes", the following resolution was adopted:

# BE IT RESOLVED BY THE ETOWAH COUNTY COMMISSION: That the following item was approved:

To adopt the FY 2016-2017 General Fund Budget (001) with a 1-step pay raise for classified employees and a  $2\frac{1}{2}$ % pay raise for unclassified employees.

During the discussion Commissioner Overstreet stated the deficit went from \$565,000 when they first started discussing the budget and had increased to \$815,000. 'We can't keep doing this and keep the county solvent.'

To add an additional deputy for the Sheriff's Office including payroll and personal protection equipment to the General Fund Budget, Sheriff's Office.

Commissioner Fuller asked if there were any reports from the staff at this time. There were no reports.

## **SCHEDULED PUBLIC HEARINGS:** None

## **DISCUSSION BY COMMISSIONERS:**

Commissioner Statum thanked all the employees and said he agreed with Commissioner Overstreet. 'We have to make hard decision over the next few months'. He added that we cannot add taxes and fees to raise money and we don't create the law. The money we have comes from different taxes that sometimes have to be used for specific things. He said he was committed to push for less days / more pay. He things we have to make a consolidated effort to pay more in wages and reduce the vacation package for future employees or give an option.

Commissioner Payne and Commissioner Overstreet did not have anything to add.

Commissioner Choate thanked everyone for the prayers he requested for his stepson and said he was much better.

Commissioner Fuller said Mr. Grant would be inheriting the future issues in dealing with a way to get more money for the county. He said it was going to take the county working with the legislative delegates to make things better. He also thanked Kevin Dollar for his hard work on getting a budget together.

**ADJOURN**: The Chair then entertained a motion to adjourn the meeting. Upon motion of Commissioner Choate, seconded by Commissioner Payne, with all other members voting "yes", the motion was passed. The meeting was adjourned at 11:35 am.
