

**MINUTES OF THE REGULAR MEETING  
OF THE ETOWAH COUNTY COMMISSION  
ETOWAH COUNTY, ALABAMA  
January 17, 2017**

The Etowah County Commission met in a regular meeting on the 17th Day of January, 2017. Commissioner Choate called the meeting to order at 10:02 am. Commissioner Payne led the Prayer and the Pledge to the Flag.

**PUBLIC COMMENTS FROM CITIZENS:** None.

**AWARDS, PRESENTATIONS, PROCLAMATIONS:**

Commissioner Choate presented a Proclamation to Senator Phil Williams on behalf of the *Association of County Commissions of Alabama* to express appreciation to the Senator for Passage of Acts 2016-127 (which insures counties can secure specialized legal representation to negotiate and litigate complex property tax appeals) & 2016-164 (which advocates for the state's juvenile justice system to include more equitable state and municipal participation and limits the county's role in the care and detention of youth held pursuant to state or municipal laws). Senator Williams discussed the importance of being able to use outside council on such issues as Lowe's trying to get their property declared a lower value by stating they will have a harder time reselling their property due to limited uses. We have a perfect example of a Lowe's store that was sold to Academy when they build a new store in Etowah County. He also said he was meeting with the Legislators about the cost of juvenile probation.
