

**MINUTES OF THE REGULAR MEETING

January 5th, 2021**

The Etowah County Commission met in a regular meeting on the 5th Day of January, 2021 at 10:00 am with the Acting President Joey Statum calling the meeting to order. He then recognized Jamie Grant as the 2021 President and passed the gavel to him. Jamie Grant asked the Prayer and the Pledge and continued the meeting.

**REPORTS FROM THE STAFF:**

**Chief Administrative Officer:** Shane Ellison, CAO, said they had been giving priority to the CARES ACT money and making sure the County was reimbursed for the eligible charges. Congress voted to extend the deadline and the counties are waiting on the state to honor the extension. They have also set up screens with cameras and microphones in the Chamber to make it easier to do a combination Zoom/In Person meeting and they are also continuing to work on the ICE numbers. County Attorney, Jim Turnbach, checked in prior to the meeting but was unable to attend today.

**DISCUSSION BY COMMISSIONERS:** Commissioner Jamie Grant called on visitor Mike Mitchell with Waste Management and he was just there to give out a few business cards and to let the Commissioners know that they were continuing with their purchase/merger of Advanced Disposal and to let him know if there were any issues.

Commissioner Johnny Grant asked how we were on State inmate reimbursements and he and Kevin Dollar discussed some of those numbers. Kevin has also filed for some reimbursements that we haven’t received yet. They have received close to \$2 million between CARES ACT and FEMA.

Commissioner Ramsey thanked Kevin for all of his work on the budget and also welcomed Jamie Grant as new Commission President. He commended Sheriff Horton on surviving the year with the way it has been.

Commissioner Inzer thanked Kevin and said a lot of the budget information was over his head and a lot of numbers but he thanked Kevin for his explanations and help with understanding. He said he knew it was hard to plan with the ICE issues but they need to stay on top of everything. He also thanked Robert Nail and the Road Department for all they do.

Commissioner Statum commended Commissioner Washington on the great job he did in 2020 as Commission President. He said Commissioner Washington would be recognized with he is able to meet. He thanked all of the Commissioners for their hard work because it takes a team. They each have different personalities and bring something to the group. He also commended Jamie Grant and thanked Kevin Dollar for all he does. He congratulated Shane on getting through his first year as CAO. He said to keep everyone in their prayers during these tough times because there were a lot of people sick or with sick family members and a lot of people that are losing family members during this time. He said he was looking forward to 2021 and had a new grandson.

Commissioner Jamie Grant thanked everyone. He said Commissioner Washington was a great friend and thanked him for all of his help. He also thanked Robert Nail for the truthful answers concerning road issues (even if it’s not what anyone wants to hear). He said he believed the County was moving in the right direction and thanked everyone.

**ADJOURN:** The Chair then entertained a motion to adjourn the meeting. Upon motion of Commissioner Joey Statum, seconded by Commissioner Craig Inzer, with all other members voting “yes”, the motion was passed. The meeting was adjourned at 10:32 am.
