Commissioner Jamie Grant called the meeting to order on the 6th Day of July, 2021 at 9:00 am with Commissioner Joey Statum asking the Prayer and leading the Pledge to the Flag.

AWARDS, PRESENTATIONS, PROCLAMATIONS, OR ANNOUNCEMENTS:

Shane Ellison, CAO, presented Jeff Little, Personnel Director, his 5 year Certificate.

Advanced Disposal will have open top containers at four locations between 7:00 am and 12:00 pm for residential cleanup of household trash on **Saturday, August 7, 2021.** They do <u>not</u> accept tires, batteries, appliances or hazardous waste.

Locations of containers:

Leeth Gap and Sardis Road – across from old County Shop Intersection of Hwy 278 & Hwy 132 Whorton Bend Volunteer Fire Department Gaston High School at Hwy 411 North

Representative from Family Success Center were here to make the Commission aware of their programs to target abuse in homes over the summer. They have a program called 'Paint the Town Blue' to make everyone aware to try to catch the abuse early. They try to have school programs to work with children from Kindergarten to $10^{\rm th}$ grade because many children do not realize their life is not 'normal'. They would just like to encourage citizens to support the blue ribbon program.

Eric Wright with the Extension Office said they were giving out gardening kits at the office. He also went over a couple of upcoming events with a Tomato Face-Off at the Farmers Market on the 24th to discover the best tasting tomato in the county and also to showcase some dishes that can be made with tomatoes. Also, on the 28th, there's a lunch meeting to discuss with Commissioners the programs they would like to see through the Extension Office.

Burt Hankins with Goodwyn, Mills, and Cawood was at the meeting with letters and pictures from Waites Construction to give an update on the Little Canoe Creek mass grading project. He said when that property gets wet, it takes 3 or 4 days to dry out. They have been moving equipment in for the last 2 weeks to prepare for starting back. They are going to start on the part close to the railroad and they still have to put in a culvert. This culvert has an arch so the bottom can stay natural and then they will complete the railroad crossing. This will allow Alabama Power to be able to get started on their substation and will also allow Tim Ramsey to get the road repair that everyone has been using for a detour. (Canoe Creek North). Mr. Hankins said the culvert installation will be more like a 30-day process (when asked by Tim Ramsey to give an estimate). Shane said they requested the change order date to be revised but will have to get a new date from the contractor. Tim Ramsey wants to leave the date like it is and they can extend it at that time. (It will give them a closer estimate as to when they will finish). The change order will be on the next agenda.
