PUBLIC COMMENTS FROM CITIZENS:

Dr. Farrah Hayes, Executive Director of the Challenger Learning Center of Northeast Alabama, along with Dr. Martha Lavender, Mrs. Teresa Rhea, and Mr. Tony Smith, came to the meeting today to thank the Commissioners for their continued support, because of their willingness to commit it has opened several doors for them. It allows them to offer services to our school systems that they would not have access to otherwise. Construction has started on the building with a planned opening of January 28, 2026, the 40th Anniversary of the Challenger Explosion. They plan on having virtual activities in classrooms across the county before opening. They have also recently received a \$100,000 grant from Alabama Power and pledges from the commission, Rainbow City, Attalla, Hokes Bluff and Southside. Etowah County is the service area for the Challenger Center but the plan to expand beyond Etowah County to 12 surrounding counties with a focus on STEM Education. They intend to bridge the gaps in teaching, with their hands on Challenger simulator and activities in one part of the building. In the second section of the building the STEM Center with activities that align with the State standards and reinforce what students are learning in school. Specifically reinforcing what is on the ACAP Tests. In April she is aiming to be in all 4th grade classes in Etowah County and Gadsden City Schools. They also plan to offer summer camps of different themes and partner with 21st Century and Etowah County Schools to offer as many after school programs as they can, after opening.
