Commissioner Tim Ramsey called the Commission Meeting to order on the 7th Day of January, 2025 at 9:00 am and Scott Hassell, Probate Judge, asked the Prayer and led the Pledge to the Flag.

#### **AWARDS, PRESENTATIONS, PROCLAMATIONS, OR ANNOUNCEMENTS:**

Sonny Brasfield and Lauren Hodge with ACCA is here to present a plaque of appreciation to Representative Mack Butler for his sponsorship of Act 2024-391, which revised the sales tax exemption process for durable medical equipment. The county had to pay a large tax refund which we were not prepared for.

Shane Ellison, CAO, presented Tim Ramsey a proclamation highlighting the achievements of the commission under his leadership as president in 2024.

Tim Ramsey thanked everyone, it has been a great year to work with this group and they have accomplished a lot of positive things for our county and excited to be here getting ready for the upcoming year. It has been an honor to sit as president.

Joey Statum thanked Tim for his service and a lot was accomplished and we're going to keep it going thru the next year. This is his 3<sup>rd</sup> term being president and this will be his last term and he is honored; 3<sup>rd</sup> time a charm. They've accomplished a lot since 2010.

Judge Hassell, 2024 incredible year for the probate office; Such respect for Mr. Ramsey for your dedication on a local and state level for mental health; the election in Etowah County went smooth thanks to the commission support of student poll workers.

Eric Schavey with the extension office, if you are seeing something in the community that needs to be addressed that they can help with do not hesitate to give them a call.

Ceandra James, Marketing Director with Blue Print University, wanted to introduce herself and company. They are a one stop shop for entrepreneurs and are excited to work with the commission in the upcoming years.

Robert Nail, County Engineer, they are preparing for the anticipated winter weather on Friday. Will keep an eye on the weather and will stage equipment on Thursday if it is necessary. Jamie asked about pretreating roads but we do not have the ability to pretreat roads. Rebuild Alabama plan we were able to address issues on 24 roads and was under budget. One road still needs stripping. Pleasant Valley Road still needs to be let and will be a p.o. project thru the state. Collections will be a little bit higher than expected. This year, the price for tar and gravel went down a little bit and asphalt stayed the same. They were able to start on the 2025 plan, started 7 of the roads in Oct and Nov. The Sunset Estates subdivision in Sardis, 6 lot minor subdivision, all adjoining owners were notified via mail with no response. So there appears to be no opposition from the community.

Also, thanked Sonny and Lauren for their leadership and the future is looking well. This board cares about the County and doesn't take things personal, it's all about the people and he appreciates everyone for being here.

Commissioner Washington said six years ago he had one goal, to bring our county and community together and it takes everyone to be great. The Commission pulls together for our county for any issue. Mr. Washington has learned a lot from Mr. Brassfield, one being, do what we need to do to be great. 2025 is a year of completion.
