Commissioner Joey Statum called the Commission Meeting to order on the 18th Day of February, 2025 at 9:00 am and Scott Hassell, Probate Judge, asked the Prayer and led the Pledge to the Flag.

Dr Alan Cosby with Etowah County Board of Education, Keith Blackwell with Gadsden City Board of Education and Jeff Colegrove with Attalla City Board of Education was at the meeting today to talk about the need for a special election regarding funding for public schools. Currently it will expire in 2026 and without this funding it would be detrimental to all 3 of our public-school boards.

DISCUSSION BY COMMISSIONERS:

Commissioner Inzer thanked everyone for showing up and he will do his part in helping rally for the election. Please keep the commissioners in the loop, as in if they need to come to some of these programs/graduations or wherever they have the ability to help accomplish the goal. He is very excited about the SEEDS grant for the Megasite. If there is ever a chance we can get tax dollars to help, we should. The money is going to be spent somewhere in the state for economic development, why not Etowah County.

Commissioner Statum – anytime we get grant money to come back to Etowah County is exciting. He appreciates everyone working together for the county. We had a vision; we saw it thru and we’re getting closer and closer every single day. This will affect numerous people in our area.
