Commissioner Johnny Grant called the Commission Meeting to order on the 6th day of January, 2026 at 9:00 am and Scott Hassell, Probate Judge, asked the Prayer and led the Pledge to the Flag.

Judge Hassell gave an update from 2025 – Commitment cases have increased 20% but mental health hospital admissions decreased 39%. There was a 1.7% decrease in cases but Etowah County is in the top 5 in the state for adoption cases. Indigent burial cases are also on the rise.

- G. To have the final reading and approval to appoint Jim Slick to the Etowah Gadsden Healthcare Authority Board of Directors. This will be a four-year term.
- H. To approve the request of Kevin Dollar, Deputy Administrator/CFO, to transfer one Ford Expedition VIN # 1FMJU1J84REA08004, from the Commission Office to the Emergency Management Agency, effective December 17, 2025.
