

**MINUTES OF THE REGULAR MEETING  
OF THE ETOWAH COUNTY COMMISSION  
ETOWAH COUNTY  
March 11, 2025**

Commissioner Joey Statum called the Commission Meeting to order on the 11th Day of March, 2025 at 9:00 am and Shane Ellison, CAO, asked the Prayer and led the Pledge to the Flag.

**PUBLIC COMMENTS FROM CITIZENS:**

Isha Bothwell with Carver Wildcats Academy was at the meeting today, to ask for donations from the Commissioners for their annual Flashback Weekend fundraising event. The Wildcat Academy has been operating for 19 years and provides guidance and structure for youths in our community. They offer educational and nutritional services and back to school drives. Flashback Weekend is the academy's largest annual fundraiser to help support their endeavors in continuing to serve the youth in our schools and community. Flashback Weekend will be April 18-20<sup>th</sup> and this will bring several sources of revenue (hotels, restaurants, shopping) from thousands of out-of-town guests, alumni and their families. They are asking for \$3,000 to help with expenses.

Eric, Torie, and Christina with the Extension Office came to speak to the Commissioners today. March and April are MOVE AL months, encouraging everyone to engage in physical activity. Eric also spoke about Etowah being one in five counties to receive the Thriving Communities Grant. This grant helps with several projects. As in, this week they will be conducting a walk-ability study at Stiplin Elementary School to try to make it a more comfortable, safer environment for kids walking to and from school. Torie and Christina spoke about their SNAP-Ed Program. It teaches nutritional education and physical activity for the community. They are in several elementary and middle schools and food pantry's, to help make the healthy choice the easy choice. Their pop-up challenge event is called Healthy Hoops at the East Gadsden Community Center is March 28<sup>th</sup> from 1:00 to 3:00. This event aims at getting children excited about playing, moving and being active.

Emma Clapp and Katie Bohannon with Family Success came to the meeting today to update the Commissioners about Family Success and their upcoming annual fundraising event – Talk Derby to Me. This fundraising event helps make possible that Family Success continues to provide over 40 diverse programs geared towards the success of families in our communities. In 2023-2024 they provided over 270,000 units of service to our community. They have programs in every school in Etowah County and 57% of cases are from county residents. All funds raised from this event ensures these programs, plus 5 new programs in 2025, remain available for our community. The Derby event will be held May 3<sup>rd</sup>, 2025.
