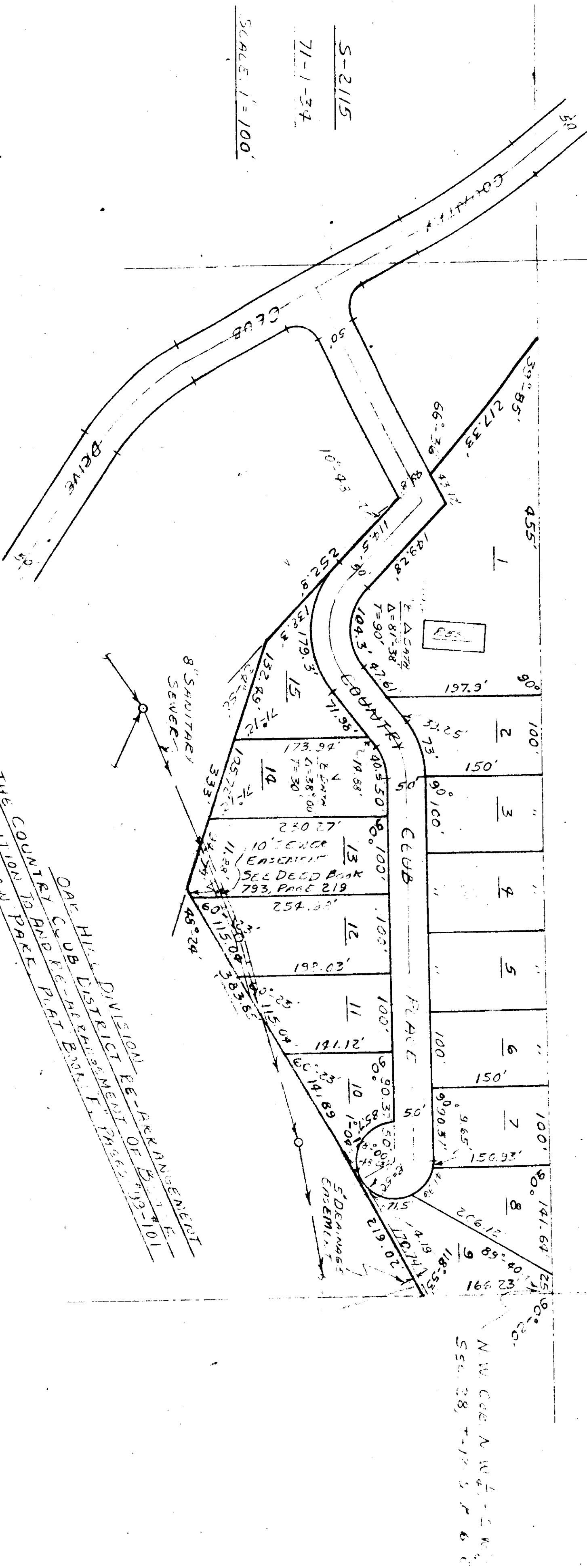


COUNTRY CLUB PLACE SUBDIVISION
