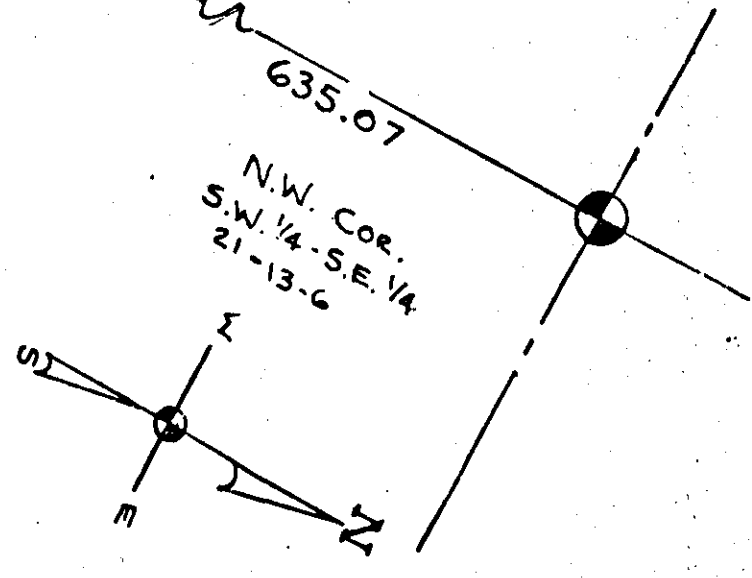
RESIDENTIAL SUBDIVISION

T19S, R3E AND NW 1/4 NE 1/4, SEC 28 T19S, R3E

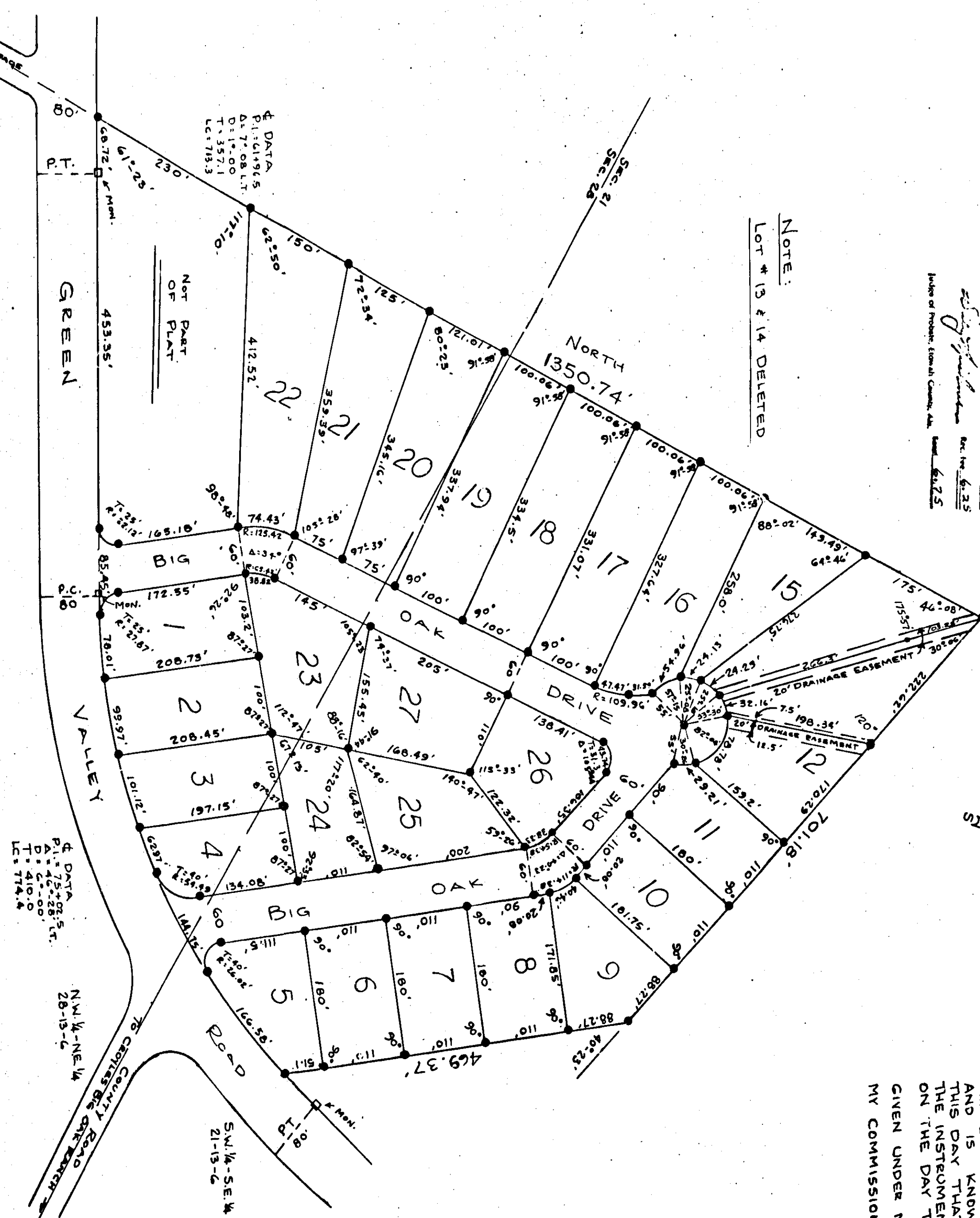
